3. Whilst you are at Hilltops you are responsible for the property and contents, and should you wilfully damage or remove from the house any furniture, utensils or other items in the house, you and your party will be liable for the cost of repairs and replacements. Please advise us immediately of any breakages or damage so that we can attend to replacement for the next guests.
4. Please put all dirty dishes in the dishwasher and turn it on before your departure. Remove all your personal items from the fridge and freezer and put all rubbish into the outside bins. Failure to do so may result in additional cleaning charges. Rubbish collection by the Council is on Tuesday morning. Please put red lidded bin on the footpath when you leave.
5. No bait is to be stored in the refrigerator.
6. Please remember our neighbours and do not make excessive noise as this can result in the immediate termination of your tenancy.
7. Occupation of the property is strictly limited to the number of people as indicated in the booking form. We will charge a supplement if extra people have stayed in the house.
8. If you should cancel outside of one month of your arrival date, we shall retain 50% of the booking total. If you should cancel inside of one month of your arrival, we shall retain 100% of the booking total. We will make every effort to rebook your dates in which case only an administration charge will apply.
